**ANNOUNCEMENT ON AIR BAG TRIGGER SUSPENSION**

Unless otherwise defined, the capital terms in this Announcement shall bear the same meaning in the relevant Supplemental Listing Document dated 2 July 2019 in relation to the DLCs.

SG Issuer (Issuer) would like to notify the holders of the European Style Cash Settled Short Certificates relating to the ordinary shares of Singapore Airlines Limited (Underlying Stock) with a Daily Leverage of -5x with counter code DSLW (DLCs) that the Underlying Unit price increased by more than 15% at 9:00:56 a.m. (Trigger Time) on 6 May 2020, and the Air Bag Mechanism was triggered at the Trigger Time in accordance with the terms and conditions of the DLCs. Trading and market making activities for the DLCs have been suspended and the value of the Underlying Unit price will be adjusted intra-day to the New Observed Price which shall be the maximum value of the Underlying Unit, during 15 minutes after the Trigger Time.
